



Dog Boarding and Doggy Daycare Policies and Liability Waiver

THIS AGREEMENT is entered into by Sir Thomson's Crate Escape and dog owner

- 1) I (Owner) represent that I am the legal owner of the above named dog(s).
- 2) PHOTO AND VIDEO RELEASE: We love to post pictures and videos on Facebook and Instagram. Owner agrees to allow STCE to use Owner's pet's name and/or photos of Owner's pet taken while he/she is at STCE for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation.
- 3) DOG'S HEALTH: Owner further understands and agrees that Owner's dog(s) are healthy and will at all times while attending STCE have current vaccinations for rabies and distemper.
- 4) Owner is not enrolling any dog that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to attending.
- 5) Bordetella for kennel cough is optional. Even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog can still contract Kennel Cough. Owner agrees that Owner will not hold STCE responsible if Owner's dog(s) contract Kennel Cough or other dog-dog transmitted illnesses. dog is highly stressed the dog's immune system shuts down making the Bordetella vaccine ineffective.
- 6) FLEA/TICK FREE: All dogs must be flea/tick free. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner at a rate of up to \$80.00 depending on severity and size of dog.
- 7) Daycare/play time: No dog may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog daycare/play time Owner is representing to STCE that Owner's dog(s) is/are in good

health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by STCE may be required to leave daycare/boarding.

8) RELEASE OF LIABILITY: Safety is our #1 priority. Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by STEC to best avoid injury, however during play scratches, accidental puncture, or torn ligaments, and other injuries may occur despite the best supervision. We do our best to prevent any incidents but an accident may occur during play.

9) PERSONAL PROPERTY: Owner understands that your dog can and may chew up any personal belongings that you bring for overnight boarding such as bedding, toys, etc.

10) FOOD/MEDS when boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog is cared for by STCE. Owner will reimburse STCE \$5.00 per feeding if an adequate supply of food is not supplied.

11) VETERINARIAN LIABILITY AND CARE: Owner agrees for STCE to obtain medical treatment for Owner's dog(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that dog(s) may need medical treatment including anesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to STCE to use Owner's vet or nearest 24-hour vet hospital for required treatment. Yes _____ or No _____ If Yes, maximum dollar amount is \$_____.

12) WEAKENED IMMUNE SYSTEM: Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding the Owner is waiving any claim for injury or illness experienced by Owner's dog while in our care.

13) ELDERLY DOGS: Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes, our policy is to transport Owner's dog to Owner's vet or the nearest 24-hour facility if owner's vet is closed or 15+ miles away. We will contact owner immediately for further instructions.

14) GROOMING expense to be authorized by Owner. Grooming expenses may occur when dog(s) nails are too long and causing breaking of skin or deep scratches to staff or other dogs. Nail trim cost \$15.00. In addition, if Owner's dog(s) happens to soil their own fur we want your baby to be clean and comfortable and would like to bathe them at regular bath prices. We will call you, but if you cannot be reached, we request your permission to keep pets clean and safe.

15) NEUTER/SPAY: We do not require that your dog(s) spayed or neutered. However if your female is in heat we ask that you cancel your reservation with us, as at this time I have an unneutered male. If Owner brings their dog to us in heat or in season STCE can not be held accountable for accidental breedings

16) PAYMENTS are due and payable at the end of each visit. Payment may be made in cash, check or Venmo. There will be a \$35.00 fee for any returned checks

17) CANCELLATION / NO-SHOW POLICY: Cancellations must be done 48-hours prior to reservation date. If cancellation notice is less than 48-hours, and the boarding is over a busy

travel period such as: holidays, summertime, all weekends, or any time kids are out of school, an amount of one night's stay will be invoiced.

18) DAYCARE CLOSING TIME: Owner agrees that if Owner's dog(s) is/are not picked up by closing time of 6pm for doggie daycare guests then Owner hereby will be charged a late fee.

19) RIGHT OF REFUSAL: STCE reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of STCE

20) FULL FORCE AND EFFECT: Owner further understands and expressly agrees that each and every one of the foregoing provisions contained in paragraphs 1-19 shall be in force and effect and shall apply to each and every occasion on which Owner's dog(s) stays with Sir Thomson's Crate Escape for daycare, boarding, or other services, as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
